### [Exploring the Interplay between Audit Standards and Investment Patterns: A Cluster-Based Analysis of FDI and FPI Across Nations](#)

This study examines the impact of Strength of Audit and Reporting Standards (SARS) on Foreign Direct Investment (FDI) and Foreign Portfolio Investment (FPI) across 84 countries (2007–2017). SARS enhances transparency, reduces information asymmetry, and fosters investment efficiency, boosting investor confidence. Using Compound Annual Growth Rate (CAGR), clustering methods, and regression analysis, the study evaluates how governance quality shapes investment flows. The findings reveal SARS significantly influences portfolio investments, attracting higher FPI through better governance, while its effect on FDI is weaker due to FDI's reliance on long-term factors like market size and resources. Clustering analysis highlights that developed economies with robust SARS consistently attract investments, whereas resource-dependent nations with weaker governance face challenges despite their natural wealth. Strengthening SARS through international standards, enforcement, and region-specific reforms is crucial for attracting foreign investments and fostering economic resilience. For investors, SARS is a reliable indicator of market stability, particularly for guiding portfolio investments. SARS plays a pivotal role in shaping global investment patterns, especially FPI, making its improvement essential for sustainable growth and investor confidence.

### [Diversity Perceptions and Organizational Commitment as Predictors of Performance and Satisfaction](#)

---

This paper examines the impact of employee perceptions of diversity management (DM) on individual outcomes, such as job satisfaction, organizational commitment, and workplace performance, in the context of Eastern Europe, focusing on Romania. It aims to address gaps in the literature by exploring individual-level dynamics of DM, which have been largely overlooked compared to organizational or group-level analyses. Additionally, the study integrates frameworks such as Social Identity Theory, Similarity-Attraction Theory, and Resource-Based Theory to conceptualize how perceptions of inclusiveness influence employee attitudes and behaviors. A quantitative analysis was conducted using validated instruments to measure perceptions of DM, job satisfaction, organizational commitment, and individual performance among employees from various industries in Romania. The dataset includes responses collected over a specific timeframe, ensuring robust statistical analysis. The main findings of the study reveal that: (i) Positive

perceptions of DM are significantly associated with improved workplace performance, mediated by organizational commitment. (ii) Positive perceptions of DM are significantly associated with improved job satisfaction, mediated by organizational commitment. These findings provide actionable insights for organizations operating in socio-economically transitioning economies like Romania. The study contributes to the literature by applying classical theories in an Eastern European context and offers practical strategies for designing and implementing effective DM initiatives that promote inclusiveness, reduce intergroup conflict, and enhance employee engagement.

## **The Impact of Audit and Reporting Standards on Foreign Investment Flows - A Global Analysis**

---

This article explores the relationship between audit and reporting standards (SARS) and foreign investment flows, particularly focusing on portfolio investments (FPI) and foreign direct investments (FDI). Our descriptive econometric analysis highlights significant regional disparities, with developed regions like Western Europe, North America, and East Asia exhibiting higher SARS, leading to greater investor confidence and a preference for portfolio investments. In contrast, developing regions, such as Africa, Latin America, and South Asia, often have lower SARS, which poses risks for portfolio investors and fosters a reliance on FDI due to perceived stability. The study, also examines the implications of GDP per capita and overall GDP growth in relation to foreign portfolio investments. Ultimately, the article underscores the need for policy reforms aimed at enhancing audit and reporting standards in developing regions to attract more foreign investments, thereby fostering economic growth and stability.
